Notice to Members Certification Course on Information System Audit (ISA) - Online

The Institute is pleased to announce an Online "Certification Course on Information System Audit (ISA 3.0)" for its Chartered Accountant Members as a Post-Qualification Course. An information System Audit is an examination of the management controls within an information technology infrastructure and business applications as well as Information System Audit is the process of collecting and examining the management of controls over an organization's information systems, practices, controls, and operations. The analysis of evidence obtained through the IS audit process determines whether the components of the information systems are safeguarding assets, maintaining data integrity, and operating effectively to achieve the organization's overall goals and objectives.

This certification course will be conducted virtually in technical collaboration with the Institute of Chartered Accountants of India (ICAI). All the participants will be provided with a Training Certificate on Information System Audit after successfully completing 18-days virtual training course (4 hours each day in the evening from 05:30 PM to 9:30 PM). However, members of the Institute will be certified as Information System Auditor after successful completion of the course by passing module tests, submission of project reports, Viva, and passing an Eligibility Test-ET (will be conducted tentatively in November 2024) and Assessment Test-AT (will be conducted tentatively in December 2024) along with at least 90 percent class attendance. The other pertinent information shall be provided to the registered participants in due course of time.

This certification course will start on June 23, 2024. As the seats are limited, the confirmation of participation by the members will follow on a first come first register basis. Therefore, interested members are requested to confirm their participation by logging into the below link latest by June 19, 2024.
