Submission of Online Examination Form CA Membership Examination, September 2024

This is to notify to all concerned that the examination forms for the Chartered Accountant Membership Examination of September 2024 in pursuance with Rule 41 of the Nepal Chartered Accountants Regulations, 2004 can be submitted online from 29 July, 2024 (14 Shrawan, 2081) till 5:00 PM of 18 August, 2024 (02 Bhadra, 2081) with payment of normal fee and till 3:00 PM of 23 August, 2024 (07 Bhadra, 2081) with payment of late fee.

In addition to centres in Kathmandu, the CA Membership Examination will also be held in Biratnagar, Pokhara, Butwal, Birgunj, Chitwan, Nepalgunj and Dhangadhi subject to a minimum of 10 applicants in each centre. Centre with less than the minimum number of applicants will be cancelled and the applicants of those centres will be transferred to Kathmandu centre.

The examination is scheduled to be held on 18th and 20th September, 2024. The detail schedule will be published later on.

The online examination form can be submitted by logging into "Online CA Membership Examination Form" portal available in ICAN website "www.ican.org.np".
