Notice for Submission of Examination Forms CA Membership Examination June 2024 for ACCAs

This is to notify to all concerned that the examination forms for the **Chartered Accountant Membership Examination June 2024 for ACCAs** in pursuance with Rule 41 of the Nepal Chartered Accountants Regulations, 2004 can be submitted from **12 April, 2024 (30 Chaitra, 2080)** till **5:00 PM of 02 May, 2024 (20 Baishakh, 2081)** with payment of normal fee and till **5:00 PM of 07 May, 2024 (25 Baishakh, 2081)** with payment of late fee.

In addition to centres in Kathmandu, the examination will also be held in Biratnagar, Pokhara, Butwal, Birgunj, Chitwan, Dhangadi and Nepalgunj subject to a minimum of 10 applicants in each centre. Centre with less than the minimum number of applicants will be cancelled and the applicants of those centres will be transferred to Kathmandu centre.

The examination schedule shall be published later on.
