- Willing to work as resource person of the Institute to impart similar training to members of the Institute inside or outside Kathmandu valley.
- Preference shall be given to the members having experience of training or teaching professional accountancy related courses.

Based on the above criteria, a maximum of 30 participants shall be selected from the interested applicants. The interested members are requested to send an email along with their recent CV by January 31, 2024 to asmita.dhakal@ican.org.np.
