

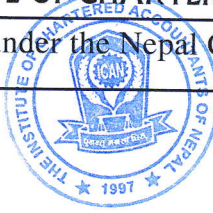

 - The bids will be opened in the presence of Bidders' representatives who choose to attend at 15.00 hours on 2082/06/02 at the office of The Institute of Chartered Accountants of Nepal, ICAN Marg, Satdobato, Lalitpur. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs. 70,000.00 which shall be valid for 30 days beyond the validity period of the bid. i.e. 15th January, 2026 (Magh 01, 2082)
- If bidder wishes to submit the Cash Security, the cash should be deposited in The Inst. of C.A. of Nepal, Deposit Account No. 17301017500176 at Nabil Bank Ltd. Bijulibazar, Nepal and submit the receipt of the deposited amount of cash along with the Bid.
